#### Call to Order

Mr. Lipscomb called the meeting to order and led the Invocation. Ms. Bonura led the Pledge of Allegiance. Ms. Bella called roll to ensure that a quorum was present.

#### Approval of Minutes

On motion made by Mr. Purgerson and seconded by Ms. Bonura, the minutes of the July 31, 2017 meeting were unanimously approved as written and circulated.

#### Budget Report

Ms. Yu provided the budget report for the period ending August 31, 2017 (See Attachment A).

Director Unangst advised that the ASC will soon implement mandatory collection by state regulatory boards of federal registry fees from all state-licensed AMCs. Inasmuch as this will increase staff workload, Director Unangst is recommending annual collection of a \$200.00 administrative fee under the authority of Subsection 3415.22 of the AMC license law. He anticipates a slight drop-off in AMC license renewal; however, the administrative fee should cover that loss. Director Unangst intends to request federal grant money offered by the ASC to assist states in offsetting the costs of complying with their collection and reporting obligations for the registry.

Board members were provided with information detailing license and renewal fees assessed by our neighboring states (*See Attachment B*). Louisiana has not implemented a fee increase for license renewal in over 12 years. Director Unangst noted that the certification law authorizes collection of a \$25.00 processing fee. This increase will be included in the renewal fee for all licensed appraisers effective January 1, 2018.

### Director's Report - None.

### Public Comment

Mr. Rieger is concerned about the Board's lack of outreach to appraisal management companies. He recommended retaining a portion of the federal registry payment in lieu of assessing a \$200.00 administrative fee. Mr. Rieger was advised that the federal government would not allow that to be done.

Director Unangst and Mr. Rieger concur about background checks being universal, with an online digital reporting system being available for all jurisdictions. Mr. Rieger advised that REEVA will actively support this method of providing background checks.

### Unfinished Business

Mr. VanDuyvendijk provided Board members with an overview of the outreach program he and Director Unangst recently offered in five locations throughout the state. The program, "Grow with the Flow", was free, and provided four (4) hours of continuing education credit to all licensed appraisers who attended. Mr. VanDuyvendijk advised that all locations were well attended. The Board thanked Director Unangst and Mr. VanDuyvendijk for their outreach to the appraisal industry.

Mr. Maynor informed the Board that the ASC requires a random 10% continuing education audit of all appraisers who renew each cycle. This year, 17% of those appraisers audited were found in non-compliance. This will require a 100% audit of all appraisers renewing their license for the 2018-2019 cycle. A hardcopy letter will be mailed to all appraisers advising them that they must mail or email proof of completion of the required 28 hours of continuing education to the Board in order to receive their renewal license.
